Dear Comrades,

Situation is very serious. Struggle is going on in different circles demanding pending wages of the contract workers. To avoid the responsibility, the Management has issued retrenchment order of the contract workers in some circles. We cannot allow it. CHQ is trying to pursue the Management. Circle and district secretaries are requested to act accordingly as the situation narrated below.

Meeting with GM (BFCI): - On 30th January,2019, Com. Animesh Mitra, Secretary General, BSNLCCWF met with Y. N. Sing, GM (BFCI), Corporate Office and explained in detail regarding the situation of the BSNL due to non- payment of wages to the contract workers. He also stated that in most of the circles, contract workers have not been paid the wages last 3-6 months. In reply, he said that he is well aware of the fact but revenue of the BSNL is reducing by leaps and bounds. All the same, he assured that he will try to allot some funds to make the payment of wages to the contract workers.

Meeting with Director (HR):- Com. Animesh Mitra, Secretary General met with Director (HR), CO on 1st February,2019 and discussed regarding the payment of contract workers. Com. Animesh Mitra, said in detail the circle wise cases of pending of payment of wages to the contract workers. In this connection, Com. Animesh Mitra, submitted the memorandum to the DIR (HR). In response, she informed that she is well aware of the situation and she will try to make the payment within few months to the all circles.

Com. Animesh Mitra, Secretary General, BSNLCCWF pointed out that the revision of the wages to the left out casual workers did not link with the 3rd PRC and is to be considered with the revision of the wages based on the 7th CPC recommendation. She assured that the necessary information has been obtained from the circles and will take the necessary action at the earliest.

18th to 20th February,2019 Strike :- It has been decided that BSNLCCWF will go on strike on 18th to 20th February,2019 on it's own 9th point charter of demands. In this regard, BSNLCCWF served the strike notice to the CMD, BSNL as well as Chief Labour Commission (C) New Delhi. Poster has been published by CHQ and put in the web site. All Circle Secretaries are requested to publish the posters in regional languages and conduct campaign programme amongst the members.

2nd Conference of Himachal Pradesh:- The Circle Conference of BSNLCCWF, Himachal Pradesh Circle was held on 06.01.2019, at Hamirpur. Com. Amarjeet Singh, Org. Secretary, BSNLEU, presided over the conference. Com. Devi Singh, Circle Secretary, BSNLCCWF, presented the report and accounts. More than 100 delegates came from different part of Himachal like Kullu, Mandi, Solan, Palampur, etc. Com.K.C. Panwar, CS, BSNLEU, A.S.Kondal, veteran leader, also spoken in the conference. The total discussion was concluded by Com.Animesh Mitra, Secretary General. The Conference has elected Com.A.S. Kondal as President, Com.Devi Singh as Circle Secretary and Com. Krishan Kumar as Treasurer. The total conference was conducted under the active leadership of BSNLEU. Specially Com.Karam Singh Thakur, District Secretary, Hamirpur, BSNLEU, who took much responsibility to make the conference a grand success.

Latest position on fund allotment:- After persuasion with the GM(BFCI) and Director (HR), now the Corporate Office has taken decision to allot some fund to the head of the circles. Circle Secretaries are requested to pursue the matter with the concerned CGM to discuss with the Corporate Office in this regard.
